

WeBenilde Terms of Use

WeBenilde is the primary platform to gather communications material for promoting De La Salle-College of Saint Benilde. It is a communications tool meant to inspire conversations among community members and a hub for information about the various developments and activities happening in the College.

WeBenilde is the major internal communications platform for the Communications Office-Center for Institutional Communications. It is a redesign of the College's Intranet and incorporates elements of B1, the community newsletter. It is a virtual place for community conversations and will chronicle and highlight the life of personnel, faculty and students in Benilde.

The following Terms of Use apply to your use of WeBenilde. Each time you access this website you agree to comply with, and be bound by, the Terms of Use and acknowledge that we may rely upon your agreement.

College Policies

Rules and regulations set by De La Salle-College of Saint Benilde in its College Policies stated in, but not limited to, the Administration Manual, Staff Manual, Faculty Manual, Academic Services Manual, and Student Handbook including, but not limited to, online conduct, will apply upon using WeBenilde. Information Access and Sharing

Information access is granted to a bona fide Benildean with activated info net and/or Benilde Mail accounts. In the process of granting access the user needs to type in his or her ID number.

Accessed and shared information in WeBenilde are subject to the provisions below:

1. Shared information are subject to the approval of the Intranet Manager/s. The Intranet Managers may not post the information if they do not adhere to the provisions of the College Policies and/or the WeBenilde Terms of Use.
2. Shared information should uphold the DLS-CSB Mission Statement.

Private sector is the key actor in the realm of the economy where the central social concern and process are the mutually beneficial production and distribution of goods and services to meet the physical needs of human beings. The private sector comprises private corporations, households and nonprofit institutions serving households.
 - c. Business entity is a unit that engages in an activity or enterprise entered into for profit.
